FACTORS TO CONSIDER

Resistance

- Rodenticide resistance has mainly occurred within the first-generation anticoagulants
- If resistance is suspected after repeated treatment failure while using a first-generation anticoagulant, switch to a second-generation anticoagulant or non-anticoagulant.

Secondary Poisoning

- If secondary poisoning of domestic animals and wildlife is of primary concern, choose non-anticoagulants or first-generation anticoagulants.

Accidental Poisoning

- There are no antidotes for bromethalin and cholecalciferol

Organic

- Cholecalciferol is the only rodenticide permitted in certified organic facilities and falls within the guidelines of the National Organic Program.
